Opened on June 20, 2018 and will close on August 2, 2018

Government of Canada departments and agencies are working to maximize release of government data and information to support transparency, accountability, citizen engagement, and socio-economic benefits.

In support of this initiative and as part of maintaining trust in Canada's regulatory system for food, plants and animals, the Canadian Food Inspection Agency (CFIA) intends to refresh its approach to openness and transparency.

This means it will proactively release more information about its regulatory and scientific activities, decisions, programs and services in useful, timely, and accessible formats, while appropriately protecting personal and confidential information.

With this consultation, the CFIA wants to hear from Canadians and stakeholders on how and where it should increase openness and transparency.

- How can the CFIA provide Canadians with more useful, timely and accessible information about food safety, animal health and plant protection to help them make informed decisions?
- Which additional information and tools could the CFIA provide to help industry comply with regulatory requirements?
- How can the CFIA share more information about its compliance and enforcement activities?
- What can the CFIA do to help stakeholders and the public learn more about regulatory science, and have access to research and information from CFIA scientists?

The input provided through this process will be gathered until August 2, 2018. After this date it will be analyzed and used to improve the <u>Proposed Open and Transparent Agency Framework</u>, helping the CFIA develop an approach to openness and transparency that balances the needs of its diverse stakeholders. A "What We Heard" report on this consultation will be published later in 2018.
